- The applicant must work for a CNLA member firm.
- CNF has allocated \$20,000 per year (\$5,000 per quarter) for this program.
- Students must pay for the course ahead of time and will be reimbursed in full upon passing the course. This applies to university courses, certification courses, training courses, etc. CNF intends to be very flexible to help as many students as possible become a part of our wonderful industry.
- Students are required to report to CNF about their educational experience via a brief essay, a speech at the CNLA Winter/Summer meeting, or a video.
- Students are not required to show financial need to be eligible.
- Courses at the CNLA Winter and Summer Meetings are exempt from this funding.
- The course must be approved by the CNF office at least 2 weeks before the class starts.
